

FIRST APPEAL ORDER

Sub:- Appeal of Dean, GCS Medical College, Hospital and Research Centre, Ahmedabad, u/s 35(5) of NMC Act against the UGMEB letter dated 18.05.2023 regarding disapproval for granting of Continuation of Recognition (COR) of MBBS degree for 150 seats - regarding.

The Appeal Committee, under the Chairmanship of Dr. Suresh Chandra Sharma, Chairman, NMC, met on 22.06.2023 at 11:15 AM to consider the above Appeal of GCS Medical College, Hospital and Research Centre, Ahmedabad. President, MARB, Member, MARB, and Member, EMRB were present in the meeting. Besides, President, UGMEB and Member, UGMEB represented UGMEB during the Meeting.

2. The Appeal dated 03.06.2023 from GCS Medical College, Hospital and Research Centre, Ahmedabad, under section 35(5) of the NMC Act, 2019, was heard which has been made against the decision of UGMEB dated 18.05.2023 (Annexure 1). Dr. Yogendra S. Modi, Dean, GCS Medical College, Hospital and Research Centre, Ahmedabad, attended the meeting online from the Appellant side.

3. Reasons for appeal:

UGMEB decision: -

(I) The virtual assessment of the medical college was done during the final MBBS practical examination from 11th to 15th February, 2023 and physical verification on 27th February, 2023 by Assessors appointed by MARB. Both the assessment reports were considered in the UGMEB and after evaluating the assessment reports along with the AEBAS and HMIS data including CCTV, the UGMEB had issued a show cause for compliance vide letter dated 01.05.2023 (Annexure-II) stating following deficiencies:

A. Subject-wise deficiency in Faculty and Resident doctors as per AEBAS record:

- (i) The attendance of Dean is 23 days out of 51 consecutive working days.
- (ii) The faculty deficiency is calculated on the basis of faculty registered by the college on AEBAS records. The attendance of these faculties is zero or less than 50% of the total working days:

- (a) Biochemistry department deficiency: Two (2) Assistant Professors and One (1) Tutor/Demonstrator.

- (b) Dentistry department deficiency: One (1) Professor.
- (c) Dermatology department deficiency: One (1) Assistant Professor.
- (d) Forensic Medicine & Toxicology department deficiency: One (1) Tutor/Demonstrator.
- (e) General Medicine department deficiency: Six (6) Sr. Resident doctors.
- (f) Pathology department deficiency: Four (4) Tutors/Demonstrators.
- (g) Pharmacology department deficiency: One (1) Associate Professor and Two (2) Tutors/Demonstrators.
- (h) Physiology department deficiency: One (1) Tutor/Demonstrator.
- (i) Radio-diagnosis department deficiency: One (1) Sr. Resident doctor.
- (j) Respiratory Medicine department deficiency: One (1) Professor.

B. Remarks of assessors assessment:

- (i) No. of Biometric devices installed in the college are 2+2. In which only 3 devices are in working condition.
- (ii) The staff working in emergency have no prior experience working in the Emergency Medicine department. However, faculty who are working in Anesthesia and Internal Medicine are shown as staff.
- (iii) The experience/eligibility of Dr. Bhandaru Sridhar, Medical Superintendent is not meeting the NMC criteria. However, other Professor named Dr. Asha N. Shah, who is working as Professor in department of General Medicine has been shown as Additional Medical Superintendent. She is eligible for the post of Medical Superintendent.

C. Other deficiency:

HIMS showed that the cameras were not functioning since last two months when checked on 24th April, 2023.

(II) The College has submitted the compliance on 05.05.2023 (**Annexure-III**) to UGMEB. The UGMEB held a virtual hearing of the college on 15.05.2023 and after hearing disapproved the college's request for CoR vide Letter of Disapproval dated 18.05.2023 (**Annexure-I**) stating the college still not qualify for minimum requirement of faculty and Resident Doctors on AEBAS and also installation/functioning of Cameras.


4. Initiating the hearing, the Chairman, NMC asked the Dean, GCS Medical College, Hospital and Research Centre, Ahmedabad to make submissions against the decision conveyed by UGMEB vide its letter dated 18th May, 2023. The Dean informed the Appeal Committee that all the deficiencies pointed out to the college has been fully rectified as per NMC norms and all the cameras are fully functioning and all faculty is also marking attendance on the AEBAS. The President, UGMEB confirmed the submission made by the Dean of the college.


